<u>POSITION IN THE TRIBAL ORGANIZATION</u>: The home health nurse is under the immediate supervision of the FNP/Nurse Supervisor and/or Medical Director. He/She works cooperatively with all members of the Medical Staff. The Home Health/Clinic Nurse is hired by the Personnel Selection Committee and is employed by the Tribe through a contract with Indian Health Services (IHS).

ROLE:

The Home Health/Clinic Nurse assists the Health Director and the Medical Staff in the implementation of health care delivery to the service population of the Pleasant Point Health Center.

DUTIES:

- 1. Works with other Medical Staff in the clinic to facilitate patient services.
- 2. Works cooperatively with nursing, medical providers, TOW and C.N.A. to provide home health services to homebound/non-ambulatory patients.
- 3. Assists in immunizations clinics, well-child care visits, and GYN services.
- 4. Works cooperatively with Sunrise County Homecare to provide home health services to the eligible Pleasant Point service population.
- 5. Be willing to learn and perform specific lab tests and prepare specimens for transport in absence of the Lab Technician and primary lab backup (TOW).
- 6. Assist Clinic Assistant in sterilization of instruments and ordering of medical supplies.
- 7. Triage of patients when necessary.
- 8. Assists patients with outside referrals and specialty services as needed.
- 9. Attends all regular and medical staff meetings, in-services, workshops and specialized group meetings as required by his/her supervisor, the Medical or Health Director.
- 10. Adheres to the Health Center back-up support system.
- 11. Performs other duties as assigned.
- 12. Actively participates as a member of the Diabetes Team.
- 13. Provides medical follow-up, outreach services to service population as needed.
- 14. Attends Quality Assurance and Review Team meeting as needed.
