

2024 ELVER TRANSACTION DEVICE RECEIPT AND ACKNOWLEDGEMENT FORM

I, _____, (Please print your name legibly) acknowledge that I understand the following bullets, by providing my signature below.

When you have signed this form, returned the form to your Tribal Office, AND paid DMR the \$35 fee, you will be eligible to receive your transaction device. **NEW IN 2024:** DMR is transitioning from the swipe card to a token. DMR will provide all license holders with a physical token which will replace the swipe card. If you have a smartphone, you may also obtain an electronic token associated with the VESL reporting app. You may use either the physical token or the electronic token to record your elver sales. The physical token and any fyke tags you may have requested will be mailed to you at the address provided to the Tribal Clerks.

- o With regard to the required use of the transaction device:
 - o I understand that I must have my transaction device (either my smartphone with the VESL app and token assigned to me OR the physical token provided by DMR) in my actual possession whenever I am fishing for, possessing, or selling elvers.
 - o I understand that I must present my transaction device to the elver dealer each time I sell or transfer elvers, and that transaction device must be used to document the sale of the elvers.

- o With regard to individual elver quotas:
 - o I understand that I have been allocated an amount of quota not to exceed 5 lbs _____(initials)
 - o I understand that I cannot go over the tribal allocation even if I have not met my 5 lb quota
 - o I understand that I may not possess or sell, in any combination, an amount of elvers in excess of the amount of quota that I have been allocated.
 - o I understand that it is my sole responsibility to keep track of the amount of elvers that I have sold in comparison to my allocation.
 - o I understand that I may not fish for, possess or sell elvers in excess of the amount of quota that I have been allocated, and that doing so may subject me to criminal penalties and license suspension.
 - o I understand that if I sell elvers in excess of the quota I have been allocated, I may also be subject to an administrative penalty equal to the value of the elvers that I illegally sold.

- o I understand that I am obligated to follow the laws and rules of as written in Title 12 of the Maine Revised Statutes and Chapter 32 and Chapter 8 of DMR's regulations.
- o I understand that I have an obligation to fully and accurately report my landings by the 10th of the following month. I understand that if I have not submitted my reports accurately and in their entirety, my license may be subject to administrative suspension for 1 year.
